# Bring Me Back Home Program

Information provided by State Trooper Josh Wedge, Troop B Canaan, CT



### What is Bring Me Back Home?

Bring Me Back Home is a new registry for Connecticut residents which allows law enforcement access to information to assist in the recovery of missing or wandering persons. The provided information and photo, accessible via the COLLECT criminal justice and safety system, helps first responderse and families reunite with individuals living with cognitive challenges, such as dementia or autism. This information is confidential and secure and can only be accessed by law enforcement personnel in an emergency.

#### How does it work?

A family member or guardian registers a loved one that has cognitive challenges through the link, or in person, at your nearest police department. The information becomes part of the statewide Bring Me Back Home registry. Law enforcement officers will have access to confidential and secure information and respond appropriately. If the loved one wanders or is missing, call 9-1-1 IMMEDIATELY, and indicate that they are registered with the Bring Me Back Home program.

### Who is eligible?

All members of the community whose cognitive challenges may lead to confusion and disorientation, and who are at risk of wandering or getting lost.

### Why is this important?

Wandering can be dangerous and life threatening. If not found within 24 hours, there is a much higher probability individuals may suffer serious injury or death. For example, according to the Alzheimer's Association, 6 in 10 people living with dementia will wander. Alzheimer's disease and other forms of dementia can cause people to lose their ability to recognize familiar places and faces. This can happen at any stage of the disease and at any time of the day or night; this risk weighs heavily on caregivers and family. The Alzheimer's Association Connecticut Chapter offers a 24/7 helpline providing information and resources for all those affected. # Volunteer Spotlight

I was so happy when I was asked to interview Pat Reilly. Pat always said hello to me at the firehouse and always listented to my stories about my goats and the time when I saw a mountain lion on our street. He was interested in me, and now I can be interested in his stories.

My first question to him was, "What makes you happy?"

He answered in two parts. First, he said "Waking up in the morning." I wasn't sure exactly what he meant, but I think he was expressing a thankfulness for life, implying that he had a positive attitude for life. I had just read the words of our forefathers: "life, liberty, and the pursuit of happiness" from the Declaration of Independence. They considered life as an "inalienable right for all," along with reaching out for happiness along the way.

So Pat is right up there with our forefathers.

His second comment on what makes him happy was "keeping busy" and throughout our interview enumerated activity after activity that keeps him busy. The one he referred to most was his work with Friends of the Goshen Public Library. As people donate their unwanted books, he "culls" them.

He says "no one likes to throw books away." The only books not accepted are encyclopedias. This year the book table at the Goshen Fair accepted a donation for a bag of books- rather than a set price per book. This was a great relief for a pastor who had no money last year and was so interested in a few books.

In addition to keeping busy, Pat likes to "keep moving." Wood is always there waiting for him to split! He says it is a "rude awakening" when the house get cold!

Helping in the community is also part of "keep moving." He is part of the EMS division of the Goshen Fire Company and is now taking a course to renew his status. Pat is a member of the Recycling and Trash Committee and is an alternate to the Finance Board. Involvment with Goshen Community Care has him looking for new members and he is glad to see younger people being active with fresh ideas.

As he was growing up in Waterbury, there were always work opportunities in factories. "You learned by the seats of your pants. You showed up. Waterbury was the brass center of the world back then and then the factories went overseas. And the corporate raiders drained the pension funds." After a successful apprenticeship at Pratt and Whitney, Pat went on to a career with the Waterubry Fire Department where he retired as a Fire Captain.



"When you are young, you are busy raising your family. Now I have time to give back. But now I don't have the physical ability, so we are looking for younger people to come in. If you are blessed with a skill or unique ability, or even just a strong back, there are plenty of opportunities to share your blessing with a local civic organization."

And with that last comment, Pat looked at the door and said, "I have to go to the library and sort books."
